Vendors must provide extension cords, power bars, table covers, shelving, etc.

You may not sublet your booth to another vendor...if you cannot attend then please notify management. You are responsible for collecting and submitting all appropriate taxes, and for having all of the necessary permits and following Federal, Provincial and Health Department regulations regarding the products that you are selling.
